- We identified factors for mortality in day 100 survivors after allogeneic HCT
  - PBSC graft, acute GVHD development, greater days hospitalized led to greater NRM
  - High-risk disease, greater days hospitalized, infection, relapse led to greater ACM
  - Higher income and BM/UCB graft sources led to lower ACM
