Postoperative Urinary Retention (POUR) is a very common post-operative complication of all 30

- surgeries (5 70%) that may lead to complications such as urinary tract infection (UTI), bladder 31
- over-distention, autonomic dysregulation, and increased postoperative length of stay (LOS). 32
- 33 Within the field of spine surgery, the reported incidence of POUR is highly variable (5.6 - 38%).
- Lack of clear stratification of surgical level, spinal pathology, and inadequate sample size is a 34
- major limitation of available studies concerning POUR following spine surgery that may lead to 35
