- A third molar maturity index(I3M) tested for indicating the legal adult age in Poland
- I3M<0.08 showed the best accurate selection of adults from minors
- Logistic regression showed that sex does not contribute to the model while I3M does
- Receiver operating curve analysis showed that I3M <0.07 select with better specificity
- I3M may be a useful method for indicating legal adult age in Poland
