Highlights:

- The normal distribution is not suitable for modeling distributions of stock returns.
- Normal mixture models with $k=3$ better represent the behavior of stock returns both statistically and economically.
- A normal mixture method is more suitable for capturing the characteristics of joint distribution of intermarket.
