Abstract: The primary goal of the current article is to “take stock” of the “other” relationships of self-assessed intelligence (SAI). The current article groups the relationships of SAI into four categories: constructs associated with intelligence (openness, emotional intelligence), tendencies and opportunities to develop intelligence (conscientiousness, education, age, SES, prior IQ test
