Professionwide awards and honors

Remington Honor Medal Calvin H. Knowlton, BSPharm, MDiv, PhD

The Remington Honor Medal, named for eminent community pharmacist, manufacturer, and educator Joseph P. Remington (1847-1918), was established in 1918 to recognize distinguished service on behalf of American pharmacy during the preceding years, culminating in the past year, or during a long period of outstanding activity or fruitful achievement.

Hugo H. Schaefer Award Baeteena M. Black, DPh

The Hugo H. Schaefer Award was established by the American Pharmacists Association in 1964 to honor the long-time APhA Treasurer, Dr. Hugo H. Schaefer, for a lifetime of contributions to the profession of pharmacy and in particular for his service to APhA. The purpose of the award is to recognize an individual who has made outstanding voluntary contributions to society as well as to the profession of pharmacy and APhA.

Hubert H. Humphrey Award Brian J. Isetts, BSPharm, PhD, BCPS, FAPhA

The Hubert H. Humphrey Award was established in 1978 to recognize APhA members who have made major contributions in government and/or legislative service at the local, state, or national level.

Good Government Pharmacist-of-the-Year Award Sandra Leal, PharmD, MPH, FAPhA, CDE

The award, established in 1990, recognizes an individual pharmacist who actively contributes to the community through his or her involvement in the political process.

Honorary Membership Roger Lea Williams, MD

Honorary membership in APhA is conferred by the APhA Board of Trustees upon individuals, either within the profession of pharmacy or outside of it, whose activities and achievements have had a significant impact upon public health, the profession, and its practitioners.

Honorary President Metta Lou Henderson, BSPharm, MS, PhD, HonD

The Honorary President of APhA is conferred by the Association upon a member who has made significant contributions to the Association.

Gloria Niemeyer Francke Leadership Mentor Award Todd D. Sorensen, PharmD, FAPhA

The award recognizes an APhA member who has promoted and encouraged pharmacists to attain leadership positions within pharmacy through example as a role model and mentor. The pharmacist for whom the award is named-Gloria Niemeyer Francke, PharmD-personally exemplified the award's criteria. Dr. Francke. 1986 APhA Honorary President and 1987 Remington Honor Medalist, inspired and mentored future leaders throughout her illustrious pharmacy career.

H.A.B. Dunning Award **CVS Health**

Established in 1982, the H.A.B. Dunning Award recognizes an exemplary contribution to the practice of pharmacy by a pharmaceutical manufacturer or provider of support products or services, or other entities such as wholesalers, chain corporations, etc. The award is named for Henry Armitt Brown Dunning (1877-1962), former chair of the board of Hynson, Westcott, and Dunning, who, as a longstanding APhA leader, was instrumental in the funding and building of the APhA headquarters in Washington, DC.

Distinguished Federal Pharmacist Award Col J. Michael Spilker, BSPharm, USAF, BSC, (Ret.)

Established in 2003, the Distinguished Federal Pharmacist Award is the Association's premier award recognizing a pharmacist who has distinguished himself or herself and the profession through outstanding contributions in federal pharmacy practice, resulting in significant improvement in the health of the nation and/or the population he or she serves. Supported by The Roche Foundation.

APhA Community Pharmacy Residency Excellence in Precepting Award Joe Moose, PharmD

The APhA Community Pharmacy Residency Excellence in Precepting Award was established to recognize a community pharmacy residency director or preceptor who has demonstrated excellence in precepting, mentoring, leadership, and community pharmacy residency program administration.

Distinguished New Practitioner Award Gretchen K. Garofoli, PharmD, BCACP

The Distinguished New Practitioner Award was established in 2010 to recognize an individual new practitioner who has demonstrated distinctive achievements in mentorship, service, and commitment to the profession of pharmacy.

Generation Rx Award of Excellence Nathan A. Painter, PharmD, CDE

The Generation Rx Award of Excellence was established in 2011 to recognize a pharmacist who has demonstrated a commitment to the mission of substance abuse education. The award is endowed by the Cardinal Health Foundation.

The Daniel B. Smith Award, established in 1964 to honor the first president of APhA, recognized outstanding performance and achievements of a community practitioner who had distinguished himself or herself and the profession of pharmacy in the recipient's community and professional practice setting. The award was merged with the APhA Practice Excellence Award in 1994 to recognize outstanding performance and achievements of a practitioner in any practice setting. Pharmacy Management Excellence Award Michael D. Hogue, PharmD, FAPhA, FNAP

This award recognizes APhA members in any practice setting who have distinguished themselves and the profession through outstanding performance in the area of pharmacy management.

Distinguished Achievement Award in Pharmacy Practice

Allison M. Dering-Anderson, PharmD, RP Dominic A. Solimando, Jr., MA, BCOP, FAPhA, FASHP

This award recognizes the achievements of an individual who has made significant or sustained contributions to pharmacy practice and has advanced the missions of APhA and APhA-APPM. The individual has developed and/or implemented an innovative, original pharmacy program or service that is significant to the nominee's area of practice.

Distinguished Achievement Award in Service Duann V. Thistlethwaite, BSPharm, BCNP, FAPhA

This award recognizes the achievements of an individual who has made significant or sustained contributions in the area of service to their community, their state, or the national level. Service activities include community service, service to the profession, and service to APhA.
