2013 ADA HOUSE OF DELEGATES SCHEDULE

REGISTRATION

For the convenience of those who attend meetings of the House of Delegates and have not registered in advance, special registration facilities are available onsite at Delegate Registration. Delegates, alternate delegates, chairs and members of councils and commissions; and officers, executive directors and staff of constituent and component societies can register onsite for the meeting when picking up their meeting materials. The onsite registration fee will apply. Those eligible for special registration also may register their spouses and other members of their families.

Former presidents, former trustees, former officers and honorary members also may register when picking up their meeting passes at the VIP area at Delegate Registration.

If meeting and housing registration is completed in advance (by 5 p.m. Central Time on Friday, Oct. 4), registration materials (badge holders, inserts, registration cards and tickets) will be mailed before annual session. Otherwise, these materials will be picked up on site.
