During the 2005–2006 academic year, she was chosen to be a Visiting Scholar at the Russell Sage Foundation in New York City. She spent the 2006–2007 academic year at the Department of Politics, New York University and the Social Indicators Survey Center, Columbia University School of Social Work.

Dr. Selda Dagistanli is a criminologist and socio-legal researcher. She is a lecturer in Criminology in the School of Social Sciences and Psychology at the University of Western Sydney. Her main research interests revolve around the intersections of Western multicultural politics, criminal justice and law, while her overarching research priority is an interrogation of the various ways in which unpopular minorities are morally, politically and culturally marginalised in legal and broader community arenas. Selda is also currently a Chief Investigator, in collaboration with Associate Professor Adam Possamai, Professor Bryan Turner from the University of Western Sydney and Professor Malcolm Voyce from Macquarie University on an ARC Discovery Project entitled, "Testing the limits of post-secularism and multiculturalism in Australia and the USA: Shari'a in the everyday life of Muslim communities".
