Highlights

- We test stock return predictability using lagged returns at the market and industry levels.
- Stock return predictability between South Africa and main developed countries is linked.
- Lagged US market return and Industry returns can predict South African stock returns.
- Return predictability varies across time and markets which reflects market liquidity.
