

Intimate partner abuse refers to any behavior in an intimate relationship that causes emotional, physical and sexual consequences to victims. It includes acts of physical abuse(slapping, hitting, biting, shoving, kicking, throwing objects); psychological abuse (intimidation, controlling stalking; neglect; and economic deprivation), force sexual intercourse (Seimeniuk, Krentz, Gish and Gill, 2010, Krug et al 2002). Intimate partner violence has many negative health problems (such as Bruises, broken bones, head injuries, and internal bleeding). Some chronic health conditions in victims of domestic violence are arthritis, irritable bowel syndrome (Berrios, 1991)) and psychological effect such as risk of suicidality (Barnett, 2001) and Post-Traumatic Stress Disorder (Vitanza, Vogal and Marshall, 1995).

Spouse abuse is prevalent in Iran (58% to 82%) in different population (Ghahari et al 2008,Ghahari et al 2009). Marital problems is prevalent in abused women and it is considered as a risk factor for abuse in relationship (Goodman et al 2005). Unresolved marital problems can reduce sex satiation and spouse abused women have low sex satiation (Allen, Swan and Raghavan,2009). About cognitive emotion strategy, Many studies showed spouse abuse women have emotion focused strategies such as avoidance and rumination (Tufighi, Emran and Soraia,1999). Lack of problem solving as a cognitive strategy is prevalent in victims of spouse abuse (Halford, 2002

Identifying thesespecific characteristic of this population could be the first step for planning appropriated programs to prevention and reduction of health issues .The current comparative study aimed at comparing the psychological variables such as Marital Conflict, Cognitive Emotion Regulation, Maladaptive Schemaand Sexual Satisfaction abused and non-abused women

2-Methods

Overall, 600 spouse abused and non-abusedwomen from Savolbolagh CityinAlborz province compared together in 2017. Convenient sampling method was used to select abused women who had referred to healthcare centers in Alborz provinc (Savolbolagh City). Screening of spouse abuse did by Ghahari Spouse Abuse questionnaire that it has validity in Iran. Another data were derived from self
