## **Highlights**

- Electrolaryngeal speakers reduce their speaking rate while using clear speech
- Clear speech does not negatively influence listener comfort
- Listeners perceive electrolaryngeal speech to be less acceptable in clear speech
- Clinical considerations warrant subjective and objective indices
