HIGHLIGHTS

- T cells naturally expressing 2 TCRs are increased in patients with cGVHD.
- Dual TCR cells are highly activated in cGVHD, indicating a pathogenic role.
- Dual TCR cells in cGVHD are Tbet⁺, suggesting pro-inflammatory function.
