EDITORS' MESSAGE



In 2017, we celebrate the fifth year of the *Journal of Vascular Surgery: Venous and Lymphatic Disorders*, the official publication of both the Society for Vascular Surgery and the American Venous Forum. Founding Editors Anton Sidawy and Bruce Perler warned us that the editors' work would be relentless but also overwhelmingly rewarding. We soon learned that they were accurate on both accounts! However, what has particularly pleased us has been the extent of support we have received from our editors, editorial board members, reviewers, and editorial staff. Success comes from teamwork and the *JVS* publications have that tradition. With this expert team's help, we have been able to rapidly introduce new features to *JVS-VL*. We are also well aware that the journey to continuously improve is challenging and never-ending. We recall, however, what Winston Churchill once said that the length of the journey "only adds to the joy and glory of the climb".

In 2015, JVS-VL was listed on MEDLINE, all articles have been retroactively cited since Volume 1 in 2013, and they are searchable on PubMed. In 2016, we received our first impact factor of 0.833, which we expect to rise as readership increases and papers are quoted. The changes we introduced in July 2016—such as redesigning the covers of all of the Vascular Surgery Journals to reflect each journal's focus on a specific area of vascular disease management—has received an enthusiastic response. The JVS-VL blue color reflects the journal's commitment exclusively to venous and lymphatic disease, concomitant with the decision that all venous papers will be published in JVS-VL. We encourage and solicit submissions from other specialties that manage venous and lymphatic disease, as we anticipate that JVS-VL becomes the journal of choice for all venous and lymphatic specialists and publishes research related to venous and lymphatic disease.

The American Venous Forum has had significant and welcome input into the editorial process of JVS-VL. We have modified the JVS-VL editors and editorial board so that venous and lymphatic experts are involved. Other changes include the addition of a concise summary, written by each author and inserted into the Table of Contents, for each clinical and basic research article and the addition of a "highlights" section for each paper, written by an editorial board member, which explains why the paper was selected, how it contributes to the literature, and the level of evidence in the paper. In addition, we are now producing an editors' review video of selected papers from each issue, which can be viewed on the JVS website and the JVS App, as well as providing an opportunity for each author to produce a video of their paper. In 2017, our quarterly journal will turn into a bimonthly publication, with significantly increased page numbers, which will allow us to publish more societal and independently submitted papers and an increasing number of systematic reviews and procedural technique articles. All of these changes add up to a sustained effort to continue the evolution of JVS-VL into the world's best and most influential venous and lymphatic journal—a proud product of our two collaborating societies, the American Venous Forum and the Society for Vascular Surgery, with substantial input of all North American Vascular Surgery Societies and our international contributors.

As new Editors of the *Journal of Vascular Surgery: Venous and Lymphatic Disorders*, we would like to thank our readers for their confidence in the changes that we have made in the journals—we will continue to respond to any suggestions. We are grateful to our editors, editorial board, and reviewers who completed their tenure in 2016, often after many years of excellent service. We welcome those new to the editorial process who will join us in 2017. We also thank our dedicated staff, Jessica McEwan, Alexandria Sese, and Tyler Cosgrove, as well as Elizabeth Perill and our publisher, Elsevier, for their continuous support in producing our state-of-the-art publications.

As we journey into a new year, we wish you and your families a happy holiday season and a healthy and prosperous new year.
