We read with great interest the clinicopathological conference published by Dairot et. al. entitled "*Submucosal nodule in buccal mucosa*". We reviewed the virtual slides. Histologically, the tumor shows a cribriform pattern with capsular invasion and extracapsular invasion, the latter is evident in the virtual slides, but not in the published pictures. Basal Cell Adenoma (BCA) of the minor salivary glands is a rare, and we were able to find a single article<sup>2</sup> describing capsular invasion.
