- There is little knowledge about national palliative care guidelines at all levels of the health care organisation
- There is a problematic inconsistency between acute and palliative care at hospitals
- Poor communication and teamwork among staff are obstacles to implementation
- An opportunity for implementation is the staff's expressed need for palliative training
