Highlights

- We find that the Taylor effect is present in Bitcoin time series.
- The power d that maximizes the autocorrelation is time lag dependent.
- Exchange rate returns show a daily seasonality in the Taylor effect.
- No seasonality is seen in the Taylor effect of Bitcoin time series.
