Highlights

- We consider the problem of meeting portfolio constraints with optimal trade
- We provide a method to value illiquid portfolios with linear permanent price impact.
- After trade, the permanent price impact changes the value of the remaining portfolio.
- There could be substantial effects on the optimal trading strategy.
- The consequences on liquidity risk and capital requirements are also notable.
