A test for each article is printed at the end of a journal issue. Completed tests for an issue are to be returned to the Editor for Continuing Education along with the CE registration form and a check for the CE registration made payable to Elsevier Science Inc./ Continuing Education. A completed CE Course Evaluation form is

also required with the submission of each set of test questions. The evaluation form is included at the end of each issue.

The tests will be scored and results sent to the participant. A minimum score of 80% correct is required to receive CEUs for an issue. Answer sheets for CE credit will not be accepted after December 31st of the publication year. At the end of the journal year, the Editor for Continuing Education will notify ASHA of participant information.
